- 2. Filing of Nominations:** From 15th November 2024 to 23rd November 2024 through Google Form.
- 3. Display of Nominations:** From 16th November 2024 to 24th November 2024 by RO.
- 4. Nomination Withdrawal:** From 16th November 2024 to 24th November 2024 on written request by the contestant to RO on Email ID: elections.aigetoatn@gmail.com
- 5. Verification of the nomination:** These nominations will be verified by the returning officer in consultation with concerned District Secretaries/ CEC from 25th November 2024 to 26th November 2024.
- 6. Final Nominations:** It will be displayed by on 27th November 2024 by RO after verification of Nominations withdrawal on written request to RO on Email ID.
- 7. Election of New Governing Body of TN Circle: 01st December 2024.**
- 8. Sequence of election:** The sequence of election for the posts will be decided by the returning officer in consultation with collegiums representatives present over there.
- 9. Eligibility to contest:** Any Bonafide member of AIGETOA nominated for one post is eligible to contest for all posts in downline provided they are not elected till that time for any other post. Any Bonafide member of AIGETOA, TN Circle (including Non-Territorial Circles) can nominate themselves or by any other member.
- 10. Eligibility to vote:** As per the constitution, Circle Collegium Members eligible to vote as per collegiums list published on 14th November 2024 will be allowed to cast their vote in person and no proxy voting shall be allowed.
- 11. Dispute Resolution: The Returning Officer's decision shall be final and conclusive in case of any dispute or controversy arising out of the election process.**
